SASSAFRAS is an outdoor Art & Fine Craft festival, presented by the North Georgia Arts Guild (NGAG) in the spectacular North Georgia Mountains. The Guild's annual spring event showcases the skilled and talented artists, artisans, and fine crafters from the region. Historically, the show attracts thousands of visitors of all ages to Clayton from around North Georgia and the southern Appalachians. Proceeds from the event fund NGAG programs including scholarships for talented high school art students.

ELIGIBILITY

- Sassafras is open to Artists and Fine Crafters 18 years of age and older.
- The Exhibitor Committee is the final authority on eligibility.

MEDIA

- All work must be the original handmade or created work of the artist. Reproductions of the artists own work are acceptable.
- Work must be as represented in photographs submitted with the Artist Application. Work other than described or deemed offensive in nature may be subject to removal from the show.
- All work is juried by the Exhibitor Committee, an artist peer review. Exhibitors are selected on design, quality and presentation.
- The number of exhibitors in each medium will be limited to ensure a wide variety of art.

Manufactured goods, handmade imported items or resale items are not accepted at this show.

AWARDS Cash prizes of \$1000 will be awarded for Best in Show, Judges' Choice, and Producers' Choice.

BOOTH TYPES Note: booths types will be assigned on first come basis

- 1. Covered Pavilion, all with electricity
 - a. 9x16' NO Canopy
 - b. 11x16' w/ Canopy, weights required
- 2. Tents on Grounds 12x12 in pairs; weights/stakes are required.

BOOTH FEES All Booth Types are the same price: \$250 – or \$200 EARLY BIRD DISCOUNT for Applications postmarked by December 31st

ENTRY & FEES Exhibitors must submit the following:

- 1. APPLICATION Completed and Signed.
- 2. PHOTOGRAPHS (*DIGITAL PREFERRED* EMAIL RWSELLS@ICLOUD.COM) Four recent color photographs to be used in the jury process and for promotional purposes: 3 of most current artwork; and 1 of booth layout.
- 3. CHECK Booth Fee(s) made payable to **Sassafras Artisan Market**.

BOOTH SHARING Limited to two artists per booth. Be sure to complete the **Booth Sharing Application** on **page 4**. Each artist will be juried separately.

ACCEPTANCE & NOTIFICATION

- Receipt of application will be confirmed via email. Incomplete applications will be rejected (see Entry & Fees above.)
- Checks will be deposited on receipt of application.
- Acceptance will be confirmed via email.
- Booth Fees will be refunded if you are not accepted.
- Once Accepted, Booth Fees will not be refunded to no-shows or withdrawals.
- You will receive notification of your booth number/location and check-in time the first week of April.

<u>SECURITY</u> **Sassafras Committee** will provide uniformed security Friday and Saturday nights. However - NO LIABILITY will be assumed by the **Sassafras Committee** or volunteers for damage, loss, or injury at any time prior to or during the event.

ARTISAN MARKET

- **Do not block** walkways. All chairs, goods, containers, and supplies must be retained in the allotted space.
- Weights required for canopies in the pavilion and must be provided by the exhibitor
- Weights or stakes required for tents on the ground and must be provided by the exhibitor.
- Exhibitors are responsible for securing tents and pavilion displays against acts of nature
- Exhibitors are required to set up and remain for the entire time of the event.
- No Generators allowed
- No loud music may be played.
- The Sassafras Committee does not supply any set-up/display equipment.
- Booths should be kept neat, orderly and attractive. Goods, containers, and supplies should be stored neatly, and out of sight of the public if possible.

CHECK-IN & SET-UP

- Check-in Friday afternoon will be staggered. You will have been notified previously (see Acceptance above) of *your specific check-in time*. Please arrive no earlier than your assigned time.
- Instructions for exhibitor parking will be given at check-in.
- UNLOAD & MOVE your vehicle before beginning booth set-up. PLEASE Prevent Traffic Jams!!

EXHIBITOR BREAK-DOWN - Sunday 4:00 - 6:00PM

- Break-down must be completed and ready to load BEFORE bringing vehicles to the site.
- Break-down will begin at 4:00PM Sunday and must be completed by 6:00PM.
